This is for general information of all concerned that a committee was constituted to finalise the increment/promotional matters of faculties and accordingly the committee in its meeting held on 19-08-2020 at Rani Campus resolved the following criteria for incentives for Ph. D./ M. Phil and other higher qualifications to the faculties.

- a) Five non-compounded advance increment be given at the entry level of recruitment as Assistant Professor to teachers possessing Ph. D. Degree in a relevant discipline as prescribed by UGC.
 - Those who completed their Ph. D. Degree while in service be entitled to three noncompounded increments prescribed by UGC.
 - c) Those teachers who have acquired NET/SLET/SET in relevant/allied subjects and possess Post Graduate Degree in professional course / M. Phil degree at the entry level be entitled to two non-compounded advance increments.
 - d) Those teachers who have acquired NET/SLET/SET in relevant/allied subjects and possess Post Graduate Degree in professional course / M. Phil degree while in service be entitled to one non-compounded advance increment.
- However, a faculty is entitled to avail the benefit of advance increment for a single time in his/her service period.
- 3. The services of the teachers who had joined this University as Academic Consultant may be considered for teaching experiences for applying to any direct recruitment in teaching category provided they possess all requisite qualifications as per existing UGC Regulations at the time of appointment as Academic Consultant in the KKHSOU. However, their services shall not be counted for their promotion under Career Advancement Scheme (CAS) as their pay structure was not equivalent to Assistant Professor.
